

DIVING PLONGEON CANADA RULES SCOPE

EFFECTIVE JUNE 1, 2023

DPCS 1.0 PURPOSE

These rules and regulations are established by Diving Plongeon Canada (DPC) and shall be known and may be cited as DPC Rules, the Rules or simply, rules.

DPCS 2.0 APPLICATION

DPCS 2.1 These rules shall apply to:

- Registered participants with DPC, Members, Affiliated Clubs and diving competitions hosted in Canada.
- Any Member, club, individual or approved guest who participates in any capacity in a diving competition governed by these rules is deemed to accept, without exception or reservation, the application of these rules.

DPCS 2.2 Exceptions

DPCS 2.2.1 Participants may make requests and may receive written permission from DPC Staff for anything contrary to these rules.

DPCS 2.2.2 Organizing Committees of local competitions in Canada may depart from the DPC Rules only if:

- All participants are notified of the local rules prior to the competition in the Meet Information Package AND the local rules provide a level of safety and fairness materially equal to those in the DPC Rules.
- The competition is hosted as part of a regional, provincial, or local multi-sport Games AND the Meet Information Package is widely available prior to the competition.

DPCS 2.2.3 These rules shall not apply to any competition that may be held in Canada that is within the exclusive jurisdiction and control of World Aquatics or, which are otherwise subject to only the World Aquatics Rules of Diving.



DPCS 3.0 AMENDMENTS TO THE RULES

- **DPCS 3.1, the** DPC Rules will undergo a comprehensive review in the year following the Olympic Summer Games by the DPC Staff.
- **DPCS 3.2** These rules, including any Appendices, Guidelines or Resources may be amended for reasons of safety and fairness OR changes to sport development priorities identified by DPC Staff.
- **DPCS 3.3** Notice of these changes will be communicated to the Members and other affiliated participants via our Technical Bulletins and posted to the Rules section of the DPC website.
- **DPCS 3.4** All changes and amendments will be noted with the date of publication and will include the period over which these rules are effective.

DPCS 4.0 GENERAL COMMENTS

- **DPCS 4.1** In the event there is a conflict between the English and French versions of the DPC Rules, the English version shall prevail.
- **DPCS 4.2** In accordance with World Aquatics regulations, diving events in Canada will be separated into Mens/Boys and Womens/Girls categories and will be referred to as such.
- **DPCS 4.3** Efforts will be made to use the gender-neutral pro-nouns "they/them/their" in these rules when referring to any participant.

DPCS 5.0 AUTHORITY
